Putting up and taking down of decorations is the member's responsibility. Only two (2) small parties will be allowed at any one time, at the manager's discretion. Music is not allowed during regular Club hours. Large tent areas cannot be reserved. Any special needs or equipment must be approved by the Manager. Small parties cannot be disruptive to other members of the club.

Members are responsible for the putting up and taking down of all decorations and the removal of any equipment or supplies brought in for the party. Please see manager ahead of time when any type of music will be involved. Only one (1) private party will be allowed on any given night. The use of the gas grills will be allowed, as long as members clean them when finished. If alcohol will be served or consumed on the premises, the member in charge must return, with this application, a certificate of liability insurance. Teen or young adult parties must be supervised. One adult for every 6 children. There is a two-guard minimum @ \$16 per hour per guard. Decorating for any after hours party cannot start until ½ hour before normal club closing hour.

Reservation Due Date: 2 Weeks prior to the party. No reservation will be made without the \$100 deposit check and all paperwork must be signed.

I agree to the following:

- 1. All child and teenage parties must have adult supervision at all times. One (1) adult for every six (6) children.**
- 2. Agree to indemnify the Foxridge Swim & Racquet Club for any loss, damage or claims resulting from your use of the facilities by yourself, family guest or invitees and release the Foxridge Swim & Racquet club from any claims of loss, injury or damage which may arise.**
- 3. Agree to abide by the Rules and Regulations of the FSRC.**
- 4. No charges will be assessed if the party is canceled due to inclement weather.**

Small Party:

- 5. Pay a \$25 deposit (submitted with this application) which will be refunded in full provided the party area is cleaned up and trash deposited in the trash bins by the member in charge, and there is no damage to Club property.**

Private Party:

- 6. Pay a \$100 deposit (submitted with this application) which will be refunded in full provided the party area is cleaned up and trash deposited in the trash bins by the member in charge, and there is no damage to Club property.**
- 7. Pay is \$16.00 an hour for each lifeguard required after pool hours for a two-guard minimum. An additional lifeguard must be added if the number of swimmers exceeds 50 (maximum 75). These fees must be paid by check, at the end of the party, directly to the FSRC. If no lifeguards are needed for an after hours party, there is still a \$16/hour charge for a guard to stay and assist, make sure everyone is out on time and to check and lock-up the Club. The FSRC will be paid an extra hour if gates are not locked by 10:15 pm weekdays and 11:15 pm weekends.**
- 8. If alcohol will be served, the member must provide proof of liability coverage on their homeowners insurance, and must be attached with this application. _____**
- 9. The tennis courts will be locked and off limits during any after-hours private party. To reserve the tennis courts during a private party, please see the manager.**
